## Prior Authorization (PA) Updates Effective July 1, 2023

## MI Senate Bill 247 and Updates to the Pharmacy Prior Authorization Process

Molina Healthcare of Michigan would like to alert providers that Senate Bill 247, effective 6/1/2023, will require insurers and health professionals to perform prior authorization utilizing only a standard electronic prior authorization transaction process unless the health professional is not able to use the standard electronic prior authorization transaction process due to temporary technological or electrical failure. This Senate Bill only applies to the Molina Marketplace line of business.

For electronic pharmacy prior authorization or formulary exception requests, you may use CoverMyMeds® (<a href="https://www.covermymeds.com/main/">https://www.covermymeds.com/main/</a>) or Surescripts® (<a href="https://surescripts.com/">https://surescripts.com/</a>). If you are unable to submit an electronic request, a completed prior authorization form can still be faxed to us at 1-888-373-3059.

As a friendly reminder, each PA request should include all necessary clinical notes, lab work and medication history.
